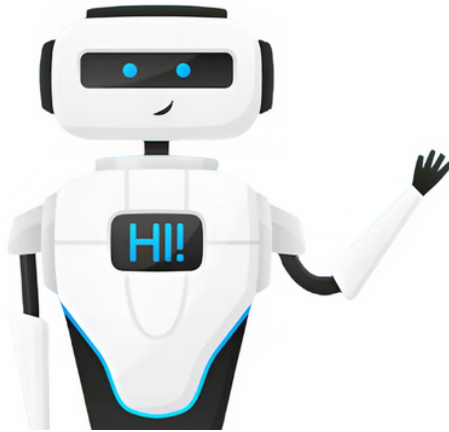

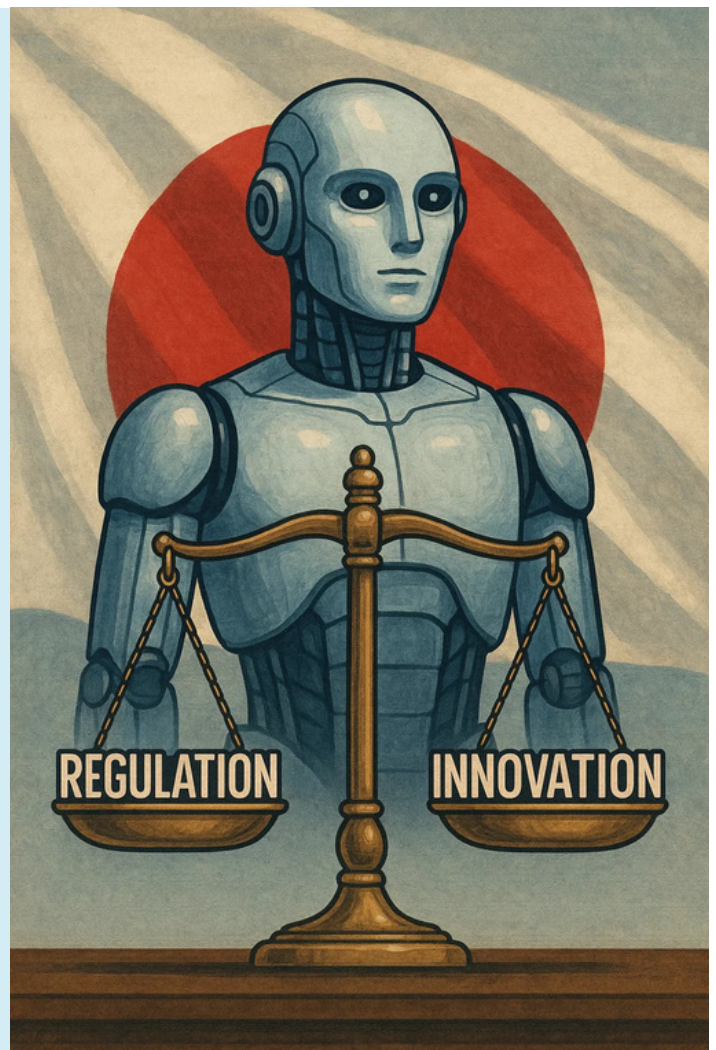
CAN YOU TRUST WHAT YOU SEE ONLINE? DELHI HIGH COURT SAYS 'NO' TO AI-GENERATED LIES ABOUT SADHGURU (03.05.2025)



The Delhi High Court ordered swift takedown of AI-generated fake videos and audios falsely depicting Sadhguru in criminal and financial scams. The Court emphasized that freedom of speech cannot extend to digitally fabricated impersonations that violate personality rights. The Court invoked IT Rules, 2021 to curb deepfake misuse. The case marks a key step toward regulating AI-generated misinformation and protecting digital identities. [Read more...](#)

CAN YOU INNOVATE WITHOUT BREAKING RULES? JAPAN THINK SO, AND THEY'VE GOT A LAW TO PROVE IT (05.06.2025)

On May 28, 2025, Japan's Parliament approved its first AI-specific law—the Act on the Promotion of Research, Development and Utilization of AI-Related Technologies—favoring a “soft-law” model rather than rigid regulation. With no criminal penalties, it empowers a Cabinet-level AI Strategy HQ, enables investigations into misuse, and permits naming offenders publicly. The goal is to balance innovation, ethical oversight, and transparency—creating Japan as a global AI leader without stifling startups or stalling progress.. [Read more...](#)





UK HIGH COURT WARNS LAWYERS TO USE AI RESPONSIBLY, SAYS THAT “SUBMITTING FICTIONAL AUTHORITIES IS A BREACH OF PROFESSIONAL DUTY” (10.06.25)

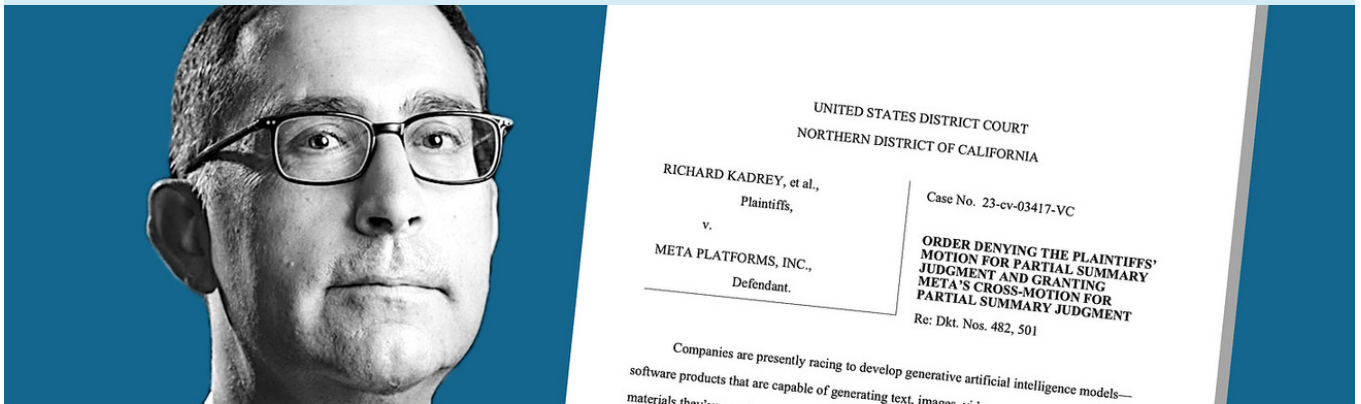
On June 6, 2025, the UK High Court, led by Lord Briss, cautioned lawyers against submitting AI-generated, fictitious legal citations. In two recent cases—including an £89 million Qatar National Bank claim with 18 fake cases and a separate housing claim with 5, lawyers relied on AI tools like ChatGPT without verification. The court stressed that “submitting fictional authorities is a breach of professional duty,” warned of sanctions, contempt charges, and possible criminal liability if left unchecked. LET AI ASSIST, NOT REPLACE : CJI B.R. GAVAI WARNS AGAINST OVERRELIANCE ON ARTIFICIAL INTELLIGENCE IN COURTS (16.06.25)



Chief Justice of India B.R. Gavai, addressing an international legal forum at Cambridge, emphasised that while AI tools like virtual hearings and translation software boost judicial efficiency, they must not supplant human judgment. He warned that AI lacks empathy and context required for fair justice and flagged the risks of algorithmic bias rooted in historical data. His message: AI should support, not decide, ensuring that compassion and human values remain central to legal proceedings. [Read More...](#)

U.S. JUDGE ORDERS IN FAVOUR OF META: TRAINING AI ON PROTECTED WORKS CAN BE CONSIDER AS A FAIR USE (28.06.2025)

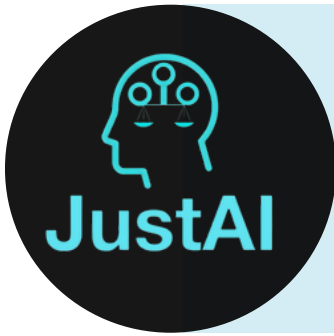


On June 25, 2025, U.S. District Judge Vince Chhabria dismissed a lawsuit by 13 authors—including Sarah Silverman and Ta-Nehisi Coates—against Meta’s LLaMA AI model. The court ruled the authors “made the wrong arguments,” finding the use of copyrighted books for AI training could be fair use, though it didn’t endorse all Meta’s practices [barrons.com+13justai.in+13apnews.com+13](#). Importantly, Justice Chhabria noted this decision doesn’t protect all instances of training, warning that different case records might yield different outcomes. [Read more...](#)



DEEPSEEK FACES EXPULSION FROM GERMAN APP STORES AMID DATA TRANSFER VIOLATIONS (30.06.25)

Germany has asked Apple and Google to remove DeepSeek, from app stores due to “illegal” transfers of user data to servers in China, outside EU’s GDPR protection. Data commissioner Meike Kamp cited DeepSeek’s failure to prove compliance with EU laws and warned of risks including surveillance and unauthorized access. The move aligns with global actions—Italy, Netherlands, Canada, and more have imposed restrictions. With no response from DeepSeek yet, this may trigger a wider EU ban. [Read more...](#)
