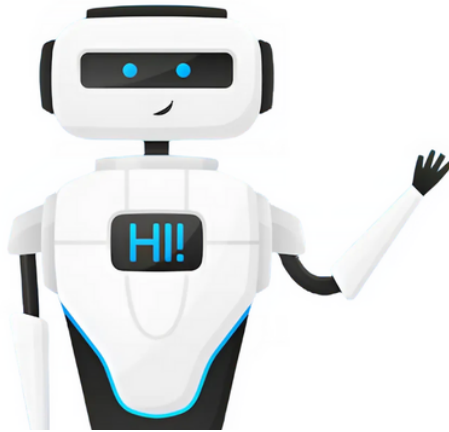

SENATE REJECTS AI LAW BAN FOR STATES FREE TO MAKE THEIR OWN AI RULES AGAIN (03.07.25)



In a major bipartisan move, the U.S. Senate voted 99–1 to remove a controversial provision from H.R. 1 that would have banned states from regulating AI for 10 years. The clause, backed by Big Tech, tied state compliance to federal funding. But facing strong opposition from governors, civil rights groups, and lawmakers across the aisle, Sen. Marsha Blackburn introduced an amendment to strike it—which passed overwhelmingly. The revised bill later cleared the Senate 51–50, with VP JD Vance casting the deciding vote. [Read more...](#)

DIGITAL IDENTITY IS NOT PUBLIC DOMAIN: DENMARK'S NEW COPYRIGHT LAW TO PROVIDE CITIZENS RIGHTS OVER THEIR VOICE, FACE & BODY (05.07.2025)

Denmark introduced a copyright amendment granting individuals legal rights over their own image, voice, and likeness. Aimed at combating the misuse of AI-generated deepfakes, the law allows citizens to demand takedowns and seek compensation for unauthorized digital imitations. It also provides special protections for performers while ensuring exceptions for satire and parody. Platforms distributing harmful deepfakes may face severe penalties, reinforcing accountability under the EU's Digital Services Act... [Read more...](#)





NO STOP-THE-CLOCK”: EU SAYS NO DELAY IN IMPLEMENTATION OF EU AI ACT (07.07.25)

On July 4, 2025, the European Commission firmly rejected calls from big tech companies, including Alphabet, Meta, Microsoft, Amazon, and OpenAI to delay implementation of the EU AI Act. A spokesperson clarified there will be “no stop-the-clock”, rejecting any grace period for compliance. The Commission emphasizes that existing transitional timelines, ranging from 12 to 24 months depending on AI risk category are sufficient. The move underlines the EU’s commitment to a risk-based, legally enforceable framework that prioritizes transparency, accountability, and fundamental rights. [Read more...](#)

On July 10, 2025, the European Commission published the final version of its voluntary Code of Practice for general-purpose AI (GPAI) models, a compliance roadmap supporting the enforcement of the EU’s AI Act, effective August 2, 2025 . Co-designed by 13 experts and over 1,000 stakeholders, the Code spans three core areas i.e. transparency, copyright, and safety/security to guide providers of powerful AI systems on how to meet legal obligations under the Act . The code guides GPAI developers such as like OpenAI, Google, and Microsoft—in aligning with the EU’s risk-based framework. [Read More...](#)
