


CHINA'S NEW AI CONTENT LABELING LAW COMES INTO EFFECT: A MAJOR STEP TOWARD DIGITAL TRANSPARENCY (02. 09. 25)



China has introduced a comprehensive AI content labeling law, mandating clear disclosure when content is AI-generated. The legislation is aimed at improving digital transparency, combating misinformation, and holding platforms accountable for AI-created content. Companies are required to implement labeling protocols for text, images, and videos produced by AI, and failure to comply may attract penalties. The law represents a significant step in global AI regulation, setting a precedent for how nations can ensure responsible AI use while protecting users from misleading or deceptive digital content. AI FOR INDIA'S GROWTH: NITI AAYOG'S VISION REPORT (03. 09. 25)

NITI Aayog's report, *AI for Viksit Bharat: The Opportunity for Accelerated Economic Growth*, highlights artificial intelligence as a key driver for India's goal to become a developed nation by 2047. It identifies two main growth levers: accelerating AI adoption across sectors like healthcare, agriculture, banking, and manufacturing, and transforming R&D through generative AI in areas such as pharmaceuticals and engineering. The report projects that strategic AI deployment could contribute up to 25% of India's GDP by 2035. Emphasizing infrastructure, governance, and workforce readiness, the report envisions AI as central to India's economic transformation and innovation leadership. [Read more...](#)



AISHWARYA RAI BACHCHAN MOVES DELHI HIGH COURT AGAINST AI MISUSE (11.09.25)



Bollywood icon Aishwarya Rai Bachchan has approached the Delhi High Court to restrain unauthorized AI-driven use of her likeness, including deepfake images and videos. The case underscores rising legal challenges surrounding digital identity rights in India. Rai seeks protection against commercial exploitation and potential reputational harm caused by AI-generated content. This development highlights the urgency of strengthening personality rights and intellectual property frameworks in the AI era. 
Singapore's Ministry of Law has opened a public consultation on draft guidelines governing the use of generative AI in legal practice. The initiative aims to balance technological innovation with professional responsibility, ethics, and client confidentiality. The draft guidance outlines permissible AI applications, risk management practices, and accountability mechanisms for lawyers employing AI tools. Stakeholders, including law firms and technology providers, are invited to provide feedback to ensure that AI integration strengthens efficiency without compromising legal standards. UNDER THE MICROSCOPE: FTC'S INQUIRY INTO AI CHATBOTS AND CHILD SAFETY (15.09.25)

The U.S. Federal Trade Commission has launched a landmark inquiry into AI chatbots, examining their potential risks to children's safety and privacy. The investigation focuses on how conversational AI may expose minors to harmful content, data misuse, or manipulative interactions. The FTC seeks input from developers, educators, and the public to shape guidelines that protect children while enabling responsible AI innovation. This move reflects increasing regulatory attention to AI-powered tools and underscores the need for robust safeguards to mitigate potential harm to vulnerable populations in digital environments. 
Italy is advancing new regulations to strengthen oversight of AI-generated content, focusing on privacy protection, deepfakes, and children's access to digital platforms. The Bill no. 1146 require labeling AI content, monitoring algorithmic impacts, and ensuring compliance with data protection laws. Authorities aim to reduce risks of misinformation, exploitation, and harm to minors. This initiative reflects Europe's broader efforts to create a responsible AI ecosystem that aligns with ethical, legal, and societal expectations. INDIA TO UNVEIL AI GOVERNANCE FRAMEWORK BY SEPTEMBER 28, 2025 (20.09.25)



At the inauguration of the AI Summit 2026, India announced that it was all set to unveil its national AI governance framework. The framework aimed to define safety boundaries around AI, establish checks and balances to protect citizens from AI-related harms, and align domestic rules with emerging global norms. Developed through over 3,000 consultations, it was designed so that some portions could later be converted into law, while others remained under regulatory or administrative practice. The framework complemented other policy measures, including rules under the Digital Personal Data Protection Act and regulation of online gaming. [Read More...](#)

UN REPORT: WOMEN'S JOBS MORE AT RISK THAN MEN'S DUE TO AI (23.09.25)



A United Nations report titled *Gender Snapshot 2025* reveals that nearly 28% of women's jobs globally are at risk of automation by AI, compared to 21% of men's roles. The disparity is attributed to women's overrepresentation in clerical, administrative, and service sectors, which are more susceptible to automation. The report emphasizes the urgency of bridging the gender digital divide, noting that women account for only 29% of the global tech workforce and 14% of tech leadership positions. The UN warns that without proactive interventions, AI could push women further into economic precarity, undoing decades of progress in narrowing the gender employment gap. [Read More...](#)



U.S. REJECTS INTERNATIONAL AI OVERSIGHT AT THE UN, RAISING GOVERNANCE ABOUT GLOBAL GOVERNANCE (28.09.25)

At the 80th United Nations General Assembly, the United States rejected proposals for binding international oversight of artificial intelligence (AI), advocating instead for national regulation and voluntary cooperation. While many nations, including the European Union, China, and India, pushed for stronger multilateral mechanisms, the U.S. emphasized that centralized global governance could stifle innovation and hinder competitiveness. This stance highlights growing fractures in global AI governance, with divergent regulatory frameworks emerging across regions. [Read More...](#)
