



DELHI HC ORDERS ON THE INFRINGEMENT OF PERSONALITY RIGHTS OF ACTOR NAGARJUN (02.10.25)

The Delhi High Court has delivered a judgment in favour of actor Nagarjuna Akkineni, granting interim protection against the unauthorised use of his identity through deepfakes, generative AI, and face-morphing technologies. The Court restrained multiple websites and individuals from exploiting his name, image, voice, or likeness without explicit consent. Justice Sanjeev Narula observed that such misuse endangers not only a celebrity's commercial interests but also their fundamental right to live with dignity. The order underscores the growing judicial recognition of personality and data rights..[Read more...](#)

ITALY TAKES STRONG STAND AGAINST AI-GENERATED “DEEP NUDE” SERVICE, SIGNALING TIGHTER DATA PRIVACY ENFORCEMENT (03.10.25)




Italy has taken action against the misuse of generative AI in creating non-consensual sexualised imagery. The national data protection regulator Garante per la Protezione dei Dati Personali issued an interim ruling on 1 October 2025 against ClothOff . The service generates hyper-realistic “deep nude” images from uploaded photos without consent, violating key obligations under the General Data Protection Regulation (GDPR), including lawfulness, transparency and data-protection-by-design. The regulator ordered an immediate suspension of processing Italian users’ data.[Read more...](#)

META'S AI CHATBOTS TURN CONVERSATIONS INTO TARGETED ADS: A BLOW TO USER PRIVACY (05.10.25)

Meta Platforms has announced that from 16 December 2025, it will start using conversations users have with its AI-chatbots across its platforms (including Facebook, Instagram and Messenger) to personalise advertisements and content. While Meta claims chats about sensitive topics (religion, health, sexual orientation, politics) will be excluded, users will have no opt-out other than avoiding AI features entirely. The move raises significant privacy concerns since conversational data is deeply personal and now becomes part of Meta's ad-targeting machine.

NEW YORK STATE COURT SYSTEM UNVEILS FIRST-EVER RULES GOVERNING JUDGES' AND STAFF'S USE OF AI (11.10.25)




The New York State Unified Court System (UCS) has issued its first-ever policy regulating the use of artificial intelligence by judges, justices, and court staff. Effective October 2025, the framework outlines strict ethical and procedural safeguards for AI use in judicial functions. It mandates formal training, restricts reliance to approved AI tools, and prohibits uploading confidential or case-related data into public models. The policy reaffirms that AI may assist court operations but cannot replace human judgment, discretion, or accountability in the judicial process.. [Read more...](#)



UAE SETS GLOBAL BENCHMARK WITH FIRST-EVER AI POLICY FOR NATIONAL ELECTIONS (14.10.25)

The United Arab Emirates (UAE) has made history by launching the world's first comprehensive policy to regulate the use of artificial intelligence in national elections. Announced by Minister of State for AI, Omar Sultan Al Olama, the "National Elections Committee Policy on the Use of Artificial Intelligence" requires all candidates to declare, register, and permit oversight of any AI tools used in campaign activities. The policy aims to enhance transparency, prevent algorithmic manipulation, and protect voter autonomy, establishing the UAE as a global leader in ethical and accountable AI-driven governance.....[Read more...](#)

INDIA EYES STRICTER AI CONTENT REGULATION: PARLIAMENTARY COMMITTEE PROPOSES LICENSING AND LABELLING TO TACKLE DEEPCODES AND FAKE NEWS (17.09.25)




Italian publishers, led by the Federation of Italian Newspaper Publishers (FIEG), have urged Italy's communications regulator AGCOM to launch an antitrust probe into Google's "AI Overviews" feature. They argue that AI-generated summaries displayed atop search results drastically reduce traffic to original news sites—by as much as 80%—posing a major threat to media sustainability. Publishers claim the feature violates fair competition norms under the EU's Digital Services Act and may constitute an abuse of Google's dominant market position. [Read More...](#)

AUSTRALIA PUBLISHES SIX-STEP AI GOVERNANCE GUIDE FOR BUSINESSES (22.10.25)



The National AI Centre (Australia) published updated Guidance for AI Adoption on 21 October 2025, offering six essential governance practices – accountability, impact assessment, risk-management, information sharing, testing/monitoring, and human control. The guidance comes in two versions: one for organisations beginning their AI journey (“Foundations”) and another for advanced governance professionals (“Implementation Practices”). It draws on international standards such as ISO/IEC 42001 and the NIST AI Risk Management Framework to help Australian businesses embed responsible AI use.. [Read more..](#)

INDIA MOVES TO REGULATE DEEPFAKES, PROPOSES AMENDMENT IN IT RULES, 2021 (25.10.25)



India is moving to regulate synthetic media by proposing amendments to the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021. The draft rules would define “synthetically generated information” (covering AI-generated or modified content that appears authentic), mandate clear labelling and metadata embedding (such as visual labels covering 10% of a video or audio identifiers during 10% of playback), and impose enhanced verification duties on major social media intermediaries.
