## INDIA RELEASES AI GOVERNANCE GUIDELINES: A FRAMEWORK FOR SAFE AND TRUSTED INNOVATION (05.11.2025)

India has unveiled the India AI Governance Guidelines, laying down a framework to promote safe, inclusive and responsible AI innovation. The document, issued under (MeitY), sets out seven “Sutras” including Trust, People First, Fairness, Accountability, and Safety as ethical foundations guiding AI development. Rather than propose an entirely new AI-law, it relies on existing legislation (like the IT Act and data protection law), augmented by targeted amendments to clarify AI-specific liabilities. A multi-pronged “three-domain” framework (Enablement, Regulation and Oversight) is introduced under the guidelines. [Read more](#)

## AMAZON VS PERPLEXITY: WHEN AI AGENTS START SHOPPING FOR THEMSELVES (6.11.25)

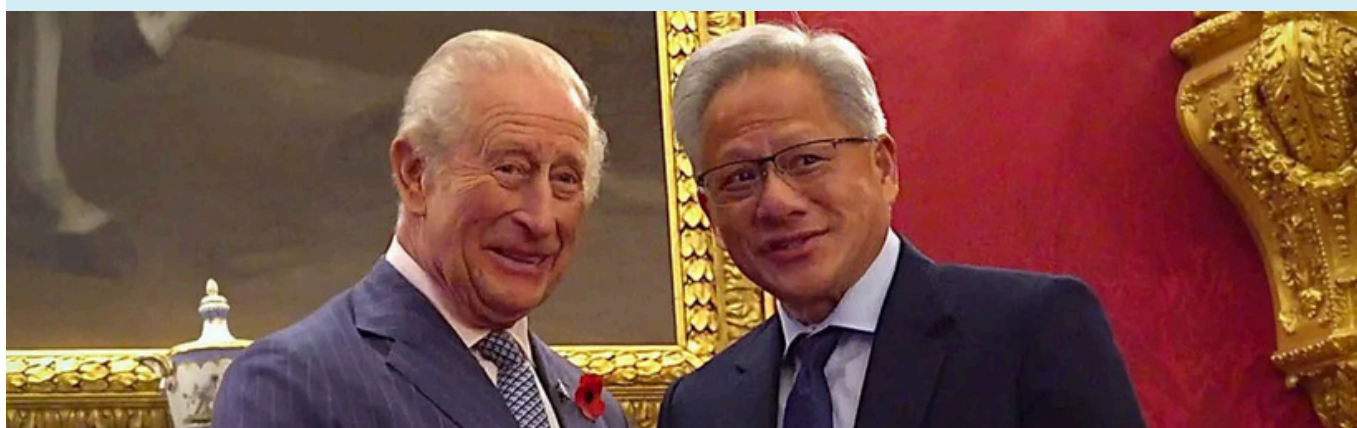
Amazon has sued Perplexity AI, challenging its “Comet” AI-agent for allegedly making unauthorised purchases on Amazon’s marketplace. Perplexity’s agent browses, compares, and buys items using a user’s account without identifying itself as an automated tool — which Amazon claims violates its Terms of Service and poses risks to marketplace integrity and consumer security. Perplexity defends Comet as a privacy-respecting, user-authorized assistant that acts as an extension of the user’s will, accusing Amazon of “stifling innovation.” The outcome of this case could reshape digital commerce [Read more...](#)

## CURTAIN-RAISER FOR THE INDIA AI IMPACT SUMMIT 2026: FOCUS ON PEOPLE, PLANET & PROGRESS (8.11.25)



The India-AI Impact Summit 2026, scheduled for 19–20 February 2026 in New Delhi got its first curtain-raiser on 7 November 2025 in Seattle. The summit will revolve around the motto “People, Planet & Progress,” structured around seven core themes (or “Chakras”) like Safe & Trusted AI, Human Capital, Inclusion, Innovation, Climate/Planet-sustainability, and Social Good. The Seattle roundtable hosted US lawmakers and tech-industry leaders who discussed AI’s potential in agri-tech, data infrastructure and global cooperation signalling India’s ambition to shape AI’s global governance [Read more...](#)

## KING CHARLES III’S AI WARNING TO NVIDIA’S JENSEN HUANG: A ROYAL REMINDER ON RESPONSIBILITY (11.11.25)



King Charles III has personally handed Nvidia CEO Jensen Huang a letter on AI safety during the Queen Elizabeth Prize for Engineering ceremony, thanking him for his company’s contributions, but also reminding him of the ethical burden that comes with advanced AI. The letter reportedly draws on the King’s 2023 address at the AI Safety Summit, warning that AI is powerful as electricity and can be used for good or ill, and urging developers to act with urgency, collective responsibility and human-centred ethics... ## AI MUST NOT BE TRAINED AT THE EXPENSE OF CREATORS: GERMAN COURT RULES AGAINST OPENAI: MUNICH COURT ORDERS OPENAI TO PAY LICENCE FEES TO GEMA (12.11.25)

# GEMA vs OpenAI

*A court in Munich has ruled that OpenAI violated copyright law by training its models on protected song-lyrics and reproducing them via ChatGPT — without a licence. GEMA, Germany's major music rights society, filed the suit over nine songs; the court found that the AI's "memorisation" of lyrics plus their later output constitute infringing acts, ordering OpenAI to pay licence fees. This landmark verdict could reshape how generative-AI systems handle copyrighted material, reinforcing creators' rights amid rapid AI growth. [Read more...](#)*



## AUSTRALIA ANNOUNCED AI PLAN FOR THE AUSTRALIAN PUBLIC SERVICE (13.11.25)

*Australia has launched the APS AI Plan 2025, a roadmap to embed artificial intelligence across the Australian Public Service (APS) with a focus on trust, people and secure tools. Under the plan, every public servant will receive AI-literacy training, and agencies will appoint senior "Chief AI Officers" to oversee adoption. A central platform called GovAI (and a secure "GovAI Chat") will provide on-shore, government-level AI tools ensuring data sovereignty, ethical use, and transparent oversight. The plan aims to combine improved efficiency with public trust, not just automation signalling a shift in how governments might govern AI deployment.. [Read More...](#)*

## WHEN LOVING AN AI BECOMES REAL ANOTHER CASE OF 'AI PSYCHOSIS' IN JAPAN (15.11.25)



*A 32-year-old Japanese woman has “married” an AI character she created on ChatGPT named “Klaus” in a symbolic ceremony in Okayama City, raising global curiosity and concern. What began as emotional support after a breakup, later evolved into daily interactions and affectionate dependence, until she felt love for the AI, which “responded” in kind. While the union has no legal standing, mental-health experts use this and similar stories to warn about a phenomenon increasingly dubbed AI psychosis where people form deep emotional bonds or delusions with AI companions. ### NEW YORK ISSUES WARNING LETTER TO AI COMPANION COMPANIES AS AI COMPANION SAFETY LAW TAKES EFFECT (17.11.2025)

*New York has become the first U.S. state to enforce a comprehensive “AI companion” safety law and has already issued a formal warning letter to firms that offer emotionally-responsive chatbots. Under the new rules (effective 5 November 2025), companies must clearly disclose that users are interacting with AI (not a human), interrupt prolonged sessions periodically, and include safeguards to detect self-harm or suicidal ideation, referring distressed users to crisis-services. Non-compliance may trigger civil penalties and potential injunctions by the state attorney general. [Read more](#)*



## EU MOVES TO EASE AI AND DATA RULES, DELAYS AI ACT TO 2027 (21.11.25)



The European Commission has proposed a sweeping “Digital Omnibus” package to simplify EU rules for AI, data protection, cybersecurity and online privacy including delaying full enforcement of the EU Artificial Intelligence Act until December 2027. Under the proposal, stricter obligations on “high-risk” AI systems (used in areas like health, credit, law enforcement, biometrics) and data-processing norms under General Data Protection Regulation may be relaxed or postponed, a move welcomed by many tech firms, but criticized by privacy advocates as a dangerous rollback of digital rights. ## EU LAUNCHES WHISTLEBLOWER TOOL AHEAD OF AI-ACT ENFORCEMENT (24.11.25)

The European Commission has launched a new confidential whistleblower tool to support early enforcement of the EU AI Act. The platform allows employees, developers, consumers, and other stakeholders to securely report suspected violations of the Act, including risks linked to high-risk and prohibited AI systems. Managed by the EU AI Office, the tool offers full anonymity, multilingual support, and encrypted communication. Its launch marks a major step in strengthening transparency, accountability, and responsible AI governance across the EU ahead of the Act’s full implementation...[Read more](#)
